**Week to Week Rental**

Our goal is for all guests to have a safe enjoyable experience. The following is a list of park policies and your agreement to follow them. These rules are for your safety and follow city/state ordinances along with company policy.

- We offer the ability to rent a site week by week in our facility. 1<sup>st</sup> week rent payment due for reservation confirmation. Last week rent payment due upon check-in. Moving forward, minimum payment of 1 week each week. (Discounted Rate: \$259.20/Standard Rate: \$288.36)  
(Please remember that this is not a long-term lease agreement. We will hold your site available for you until you give notice to vacate {1 week prior} or you begin to absorb last week paid in advance.)
- Qualification of week to week rental is determined by park management/ownership and may be discontinued at any time.
- By signing this agreement, you agree to have your card on file charged a 1-week rate if you fail to pay on “next due” date and plan to continue occupying a site.

\*\* Rate includes 2 people. Registered guests must seek approval for unregistered guests to occupy RV. Additional charges may apply for each person staying if occupancy exceeds more than 2 individuals. No subleasing.

\*\*Speed limit throughout the park is 5MPH. All lanes are fire lanes which are one-way headed west. All vehicles must enter the park near the office and exit through the west end exit. Any vehicles extending into the fire lanes are subject to tow at the owners’ expense. \*ATS Towing Services (208) 936-8118

\*\*No parking on the grass or unauthorized locations. All vehicles must be parked uniformly facing north (towards the freeway). **Each site is permitted 1VEHICLE and 1 RV.** Additional vehicles (i.e. boats, cargo trailers, additional RV’s and second or third vehicles) must be parked on the street. \*ATS Towing Services (208) 936-8118

\*\*No tampering with park property or that of other guests.

\*\*All vehicles & RV/Trailers must be licensed and registration up to date.

\*\*All RV’s must be self-contained & in proper functioning order. No LEAKS or Spills.

\*\*Quiet hours are from 10pm to 7am.

**Individual Sites:**

- A standard sewer elbow is mandatory if you plan on using our sewer receptacle.
- No tarps/plastic on RV’s. (Ask management for advice regarding winterizing materials)
- Repair of vehicles are prohibited (exceptions may be considered and approved by management)
- No stakes, carpets, mats, satellite dishes, cables, etc. are allowed on the grass.
- Keep your site orderly. Please dispose of all dog waste and household trash in dumpster immediately. (No Garbage Cans in Your Site) Keep excess belongings stored neatly/orderly under your RV. Do not hang anything from park property.
- Clean-up and prevent any leaks from RV/Trailer and vehicles.
- Only 1 RV power cord per electric box. 20/30/50 amp. (exception for heat tape in the winter)

**Restrooms/Laundry Facility:**

- *Daily cleaning begins at 11:30am.* (Facilities closed while we are cleaning)
- No sharing the restroom codes, leaving doors(s) ajar, etc. All registered guests will obtain necessary codes upon check in.
- Please pick up after yourself in our facilities. Laundry left unattended in washer/dryer is subject to removal.
- No Smoking and No Pets allowed in restrooms or laundry room.
- Do not wash/dry carpets or mats in our laundry facility.

**Pet Policy:**

- All dogs must remain on leash, under your control at all times and not exhibit any aggressive behavior to other animals or guests while in the park.-No Exceptions
- **All pets must be picked up after immediately (at all times).**
- Excessive barking is not allowed. Any complaints from guests will constitute as “warning”.

**Failure to Abide by Any Policies:**

1. **First Violation: Warning**
2. **Second Violation: Reduction of last week Deposit by 1-day standard rate. (\$48.06)**
3. **Third Violation: Forfeit remainder of weekly rate & discontinuation of rental agreement.**

**Fees, Penalties and Reimbursement:**

- If you fail to notify management that you will be departing on your last day paid, a charge of \$48.06 will be charged to your card on file.
- If you begin to absorb any days of your last week, paid in advance, we will take reservations for the site resulting in your need to vacate the property.
- Returned Check penalty of \$35 will be added to your amount due. We then reserve the right to deny personal checks going forward.
- If you depart before your rent due date, we will refund half the amount of unused days.
- For any clarification or specific needs, please see management for accommodation.

**We reserve the right to refuse service and ask anyone causing disturbances to leave the premises. Including repeated violations of any park rules, both verbal and written. Guests to your site must also follow these policies at all times. Mountain View RV Park Owners, Management and employees are not responsible for loss due to fire, theft, vandalism, accidents or acts of nature.**

If you have any questions regarding park rules or policy, please feel free to ask management. We strive to create a safe, enjoyable and pleasurable experience for all guests.
